With support from the Dutch Ministry of Foreign Affairs, and in partnership with the West Africa Civil Society Institute (WACSI), the Foundation has since 2021 been working with a number of partners to pilot innovative approaches to local resource mobilisation for inclusive development. We held learning meetings with our partners to harvest emerging lessons for wider dissemination. In the same vein, we started work during the period on the strengthening of the ecosystem for Social Enterprise in Ghana as a strategy for inclusive development and civil society sustainability.

We continued our work, with funding from FCDO, on facilitating inclusive access to quality social services, particularly health, education and social protection. The research papers we commissioned were disseminated and used as inputs for engagements with Parliament and other stakeholders.

Our Security, Stability and Development project in northern Ghana, funded by FCDO, ended during the period. The end-of-project conversations stakeholders provided very useful lessons for wider conflict, security and development programming in northern Ghana in particular.

LESSONS FROM THE COVID-19 PANDEMIC: STAR-GHANA ORGANIZES NATIONAL FORUM **ON SOCIAL PROTECTION**



Weaknesses in Ghana's social protection system were exacerbated and exposed by the Covid-19 pandemic. SGF, under its Partnerships Beyond Aid (PBA) programme funded by FCDO, commissioned a study by the Centre for Social Policy Studies (CSPS) of the University of Ghana, Legon, to improve stakeholders' understanding of the current state of SP in Ghana and identify entry points for advocacy towards a strengthened Social Protection system. A one-day national dialogue was organised by SGF to discuss the CSPS research report and agree an action plan for coordinated advocacy by state and non-state actors.



STAR-Ghana Foundation in collaboration with Africa Education Watch, SEND Ghana and Parliament's Select Committee on Education held a strategic meeting to discuss reports and surveys produced on education services delivery in Ghana. The reports included an analysis of the 2022 national budget which revealed an allocation of 12.9% to the education sector which does not meet the UNESCO threshold of 15 to 20% of expenditure. STAR-Ghana Foundation (SGF) met Parliament's Select Committee on Health to discuss findings from research it undertook on Rapid assessment of the impact of COVID-19 on health delivery, COVID-19 commodities allocations, and supply as well as Health financing and implications for policy in the health sector. The one-day strategic meeting sought to, among other objectives, provide evidence to strengthen the capacity of the committee to hold ministries, departments, and agencies to account for ensuring inclusive delivery of health services. That was the story of Martha Moses Akanpel. Martha was forced to quit school at age 17 when she got pregnant. STAR-Ghana Foundation (SGF) through its Conflict, Security and Stability Fund (CSSF) under the Regional Response Programme has developed a roadmap for coordinating advocacy on peace, security and stability in the regions of the north in Ghana. The one-year project was piloted and implemented in the five regions in the north with the objective of contributing to address the underlying causes of conflict, insecurity and underdevelopment in Northern Ghana. Among other achievements, the project has influenced operational development plans of some six ministries including the National Security Ministry,5 Regional Coordinating Councils and 10 MMDAs.







UPCOMING ACTIVITIES

AGM & ACTIVE CITIZENSHIP LECTURE

The third Annual General Meeting(AGM) of STAR-Ghana Foundation will be held in July 2022. As part of the AGM activities, a Dialogue on Active Citizenship under the theme "Channelling our Local Philanthropy towards supporting social justice, social protection and social accountability-Strategies and Tactics" will be held. The Annual Active Citizenship Dialogue has been part of the AGM since 2019. It is expected that about 100 participants drawn from Civil Society Organizations, policy makers, media, academia, and other relevant institutions would attend the event. Apart from the physical participation, an option to join virtually would also be provided to ensure the participation of all interested persons.

The Policy Lecture seeks to:

- Promote national dialogue on the concept of active citizenship and philanthropy and how it can be used to address contemporary national issues.
- Catalyse active citizenship actions at national and local levels for inclusive and sustainable national development.
- Project STAR-Ghana Foundation as a thought leader on national development issues, particularly around civil society strengthening, active citizenship, and philanthropy.

CIVIL SOCEITY TO REFLECT ON THE IMPLEMENTATION OF RTI LAW IN GHANA



Despite the passage of the Right to Information Law in Ghana, administrative and bureaucratic bottlenecks coupled with the imposition of fees by public institutions and a seeming lack of awareness among the citizenry of the law and their rights to demand for information are among a host of challenges impeding access to public information and the effective implementation of the law. Again, the measures put in place by government to contain the spread of the COVID-19 pandemic has placed an additional layer of impediments to the ease with which individuals and civil society organizations are able to access information from public institutions to hold public office holders accountable.
