#### ABOUT THE GHANA COVID-19 RESPONSE PROJECT

The response to fight COVID-19 pandemic in Ghana has been largely led by the government with little or less input from the civil society sector. However, experience from the Ebola epidemic cases in Sierra Leone has shown significant successes in the role and efforts of the civil society sector, which include the faith-based organisations and traditional/community leaders, in fighting the pandemic, particularly where these efforts involve significant changes to social and religious practices and norms. It is against this background that the STAR-Ghana Foundation is steering a programme of actions to complement and deepen planned and ongoing efforts to fight the COVID-19 pandemic. The 'Ghana Covid-19 Response Project' (CRP) supports coordinated civil society actions around Covid-19 prevention, management and mitigation.

#### **ABOUT THE COVID-19 SITREP: CURRENT SITUATION**

Since the emergence of COVID 19 in Ghana, the government of Ghana has enacted several measures to contain and prevent the spread of the virus. The three continuous weeks of partial lockdown for residents in Accra and Kumasi and closure of borders which was instituted by the government brought hardship to many vulnerable and the general populace at large. In addition, the spread of fake news and mistrust of government management of COVID-19 funds have highlighted the urgent need for CSOs and other civil society actors to monitor and track the allocation and utilisation of these resources. This Situation Report, therefore, harvests and documents CSOs responses to this crisis.



# Naymote in Liberia creates awareness and fosters community resilience

From 1 May 2020 Naymote launched its Community Action Platform Against COVID19 and implemented activities under awareness creation and mobilising community resilience with Open Society Initiative for West Africa (OSIWA) and National Endowment for Democracy (NED) funding. 24,046 citizens from 225 communities across 17 electoral districts in Montserrado County were educated about covid19 preventive measures, signs and symptoms thanks to the partnership with 45 empowered Community-based organisations and networks across Montserrado County. The project also reached and educated 13,994 youth and 427 persons living with disabilities about COVID19 signs, symptoms, and preventive measures, notably through the COVID19 TV show on SATEC TV (online media) and posting of regular updates on COVID19 in Liberia. The project increased grassroots response to the fight against COVID-19 and enhanced community engagements and ownership

Objective 3: Increase the transparency, responsiveness and accountability of government and its relevant agencies to citizens around the development and implementation of Covid-19 response plans, including the utilisation of resource.

#### YIAGA Nigeria collates citizens perspectives on how government is responding to COVID-19

YIAGA Africa has developed a leading initiative in compiling citizens feedback on government response to COVID-19 into a "Citizens Feedback on Government Response to COVID-19 Report". This report fosters accountability, transparency and responsiveness of government activities during the pandemic. The organisation deployed observers in 600 Local Government Areas (LGAs) across the country to monitor government responses related to COVID-19 and its impact on the communities. This included the distribution of relief materials, cash transfers, and other palliatives across the LGAs. It also tracked human rights abuses, gender-based violence, availability of essential services and potential impact of the pandemic on security.
